1. Introduction

MPCON Limited, Bhopal, invites proposals from eligible training providers to implement a skill development program for Scheduled Caste (SC) candidates from Below Poverty Line (BPL) families in six districts of Chhattisgarh. - Placement assistance or self-employment support for at least 70% of candidates.
- · Certification and Assessment upon successful completion.

3. Eligibility Criteria

- Bidder should have at least 5 years of existence and should be Partnership / Private Limited company
- Bidder should have minimum cumulative turnover of 2.5 Crores in last 3 years (202122, 2022-23, and 2023-24), ITR & CA Certificate to be attached.
- Proven track record of at least 500 residential candidates trained in the last 3 years of SC-BPL category.
- Proven track record of minimum 5 districts with minimum 120 Residential Candidates of Chhattisgarh for conducting SC-BPL Skill Development Training program.
- Bidder should be ISO 9001:2015 certified.
- Bidder should not be blacklisted by any means, self-certificate in letter head should be produced.

4. Proposal Submission Guidelines

- All Submitted documents should be self-certified.

- a) Amount of Residential part in Project which includes Food, Lodging & Boarding and Transportation of Candidates will be passed 100% to Bidder upon showing proper Agreements of assigned vendors by the Bidder.
- b) Also in case candidates are not willing to stay in residential facilities, transportation cost will be directly transferred to Individual candidate as decided by MPCON. Bidder will submit Beneficiary Bank Details to MPCON Limited, Bhopal. Balance amount will be transferred to Bidder of other facilities upon submitting documents and bills.
- c) Minimum 25% revenue of the Project would be of MPCON in terms of the training fee. Bids offered should be above the minimum threshold as at c and the maximum offered share to MPCON would be awarded the work

5. Security Clause

- The selected bidder must submit within 15 days a Performance Bank Guarantee (PBG) or Fixed Deposit Receipt (FDR) equivalent to 3% of the total project cost upon successful agreement between Bidder and MPCON Limited, Bhopal.

- The PBG or FDR will be forfeited in case of non-compliance with project deliverables.
